**Rules and Regulations**

**A. General Rules:**

1. Riding Club hours: 7am – 8pm and as necessary.
2. **NO SMOKING** within 50 feet of the barn, paddocks, feed storage shed, arenas, and manure piles.
3. Appropriate footwear (i.e. boots) must be worn by everyone at all times when handling horses. **Absolutely no exceptions.**
4. All motor vehicles must enter Malu'Olu Ranch through the Center gate and exit through the Kailua gate.
  - a. Speed limit is **5** mph.
  - b. Cars are not allowed in the arenas or barn areas except to make large deliveries.
  - c. Park cars only in designated parking areas. Trailer parking is assigned by the manager.
6. All visitors must check in with a Board member and sign a **Release and Waiver of Claims** form upon entering the Riding Club. The forms are located at the main stable facility. **Absolutely no exceptions!**
7. No outside horses are allowed on Malu 'Olu Ranch except for competition in horse shows or other approved activities, as determined by the manager, such as riding lessons.
8. No littering. Please use appropriate trash receptacles.
9. Use of illegal drugs and/or alcohol is prohibited.
10. Be considerate of others at all times.
11. Cruelty to or negligence involving any animal will **NOT** be tolerated at any time.

12. Valuables must be secured in your car or tack room(s). The Lessee and Lessors of the Riding Club are not responsible for lost, stolen or damaged property.

13. Horse owners must notify the Malu'Olu Board when they will be out of town, provide telephone numbers where they can be reached in case of emergency.

**B. Barn and Paddock Rules**

1. NO SMOKING within 50-feet of the barn and paddocks.
2. Do not leave horses tied unattended or let loose at any time.
3. Clean up your and your horses mess immediately.
4. **Appropriate riding clothes and footwear must be worn when handling horses.**
5. Hard hats **must** be worn by everyone while jumping.
6. Horses are not allowed in the covered nursery area.

I have received and read a copy of the **Malu'Olu Riding Club Rules and Regulations**. I accept these as a condition of boarding my horse(s) at the Riding Club. I understand that I am responsible for the actions and behavior of my minor children, family members, and visitors while on the Riding Club property. I understand that upon bringing any visitors into the Riding Club, I must **first** contact a Board Member and have my visitors sign a **Release and Waiver of Claims** form. I understand that if I employ any horse handler it is at my own risk and liability and that they must show proof that they carry liability insurance required by the riding club.
